Rental Pricing and Information

- Regular hourly trolley rental rate is **\$125.00** per hour.
- The rental rate on City holidays is **\$140.00** per hour.
- There is a minimum of two hours per rental.
- After the initial four hours at full price, a reduced rate of **\$75** is in effect.
- Security Deposit is **\$250.00**.
- All rentals include a licensed driver.
- Refunds are not given for unused time. At the time of booking, carefully consider the time needed for your event.
- Passengers must comply with all safety instructions and regulations issued by the City and the trolley driver. All passengers must remain seated while the trolley is in motion.

Non-Profit Rental Information

- Regular rate is **\$60** per hour.
- Must provide proof of non-profit status.
- Security Deposit is **\$250.00**.
- All rentals include a licensed driver.

Frequently Asked Questions

Q. Are food and drinks allowed?


A. Food and beverages are allowed in the trolley. Ice chests must be secured to the interior of the vehicle with bungee cords.

Q. Does the city require liability insurance?

A. Yes, the City of Kingsburg requires a certificate of general liability insurance.

Q. How far can the trolley be taken?

A. All trips must remain within 50 miles of the Kingsburg Corporation Yard located at 1200 Kern Street Kingsburg, CA 93631.



Frequently Asked Questions

Q. Are kids allowed?

A. Yes. If an applicant is hosting minor children, (under 18 years of age) the applicant must have an adequate number of adult chaperones and supervision. Adequate chaperones and supervision is considered to be not less than one adult per ten (10) minor children. Children must be under the supervision of a parent, guardian or chaperone at all times while on the trolley.

Q. When does the clock start ticking for my trolley rental?

A. Rental begins when the trolley leaves the Kingsburg Corporation Yard.

Q. Is the trolley handicap accessible?

A. Yes, the trolley is handicap accessible, and there is room for two wheelchairs.

Q. Are passengers required to clean up the trolley after a trip?

A. Yes.
